1.2. Which of your data are processed and to which purpose?

## Information obligations to the WLAN "Gast"



All data obtained from you will be used exclusively for your intended purposes. A processing for other aims is only considered when in compliance with the applicable legal regulations according to Art. 6 Abs. 4 DSGVO. It is understood that we will adhere to our duty to inform you if applicable according to Art. 13 Abs. 3 DSGVO and Art. 14 Abs. 4 DSGVO.

#### 1.3. What is the legal basis for the data processing?

The processing is necessary to fulfill a contract (provision of internet access through WLAN visitor) according to Art. 6 Abs. 1 lit. b DS-GVO. This contract is automatically accepted with your registration at WLAN Visitor. To ensure the proper function, we save your IP address and the corresponding data volume according to Art. 6 Abs. 1 lit. f DS-GVO. A possible transfer of data in connection with a criminal prosecution will be operated in accordance with Art. 6 (1) (c) DSGVO.

#### 1.4. How long are the data kept?

We save the data only as long as necessary to obtain the purpose for which they are needed and only in compliance with any European or other legal rules and decrees to which the data processing entity is subject.

As soon as the purpose for saving your data is no longer applicable or the legal retention period expires, the data will be deleted no later than at the next Firewall restart.

#### 1.5. To which addressee are the data transferred

A transfer of your personal data to third parties will only take place if necessary to fulfill the agreed contract, if the transfer is permitted based on the balancing of interests according to Art. 6 Abs. 1 lit. f) DSGVO, if we are legally bound to transfer your data, or if we act with your consent.

#### 1.6. Where are the data processed

Your personal data are processed only in data centers situated the Federal Republic of Germany.

#### 1.7. Your rights as person concerned

You are entitled to receive information about the processed personal data.

If a request for information is not made in written, we may ask for a proof of identity to make sure there is no misuse.

Further you have the right to correct, delete or restrict the processing of your data in line with the legal rules.

Further you have the right of objection concerning the data processing as far as allowed by legal rules. You have the right to data transferability in line with the data privacy laws.

In particular, you have the right of objection according to Art. 21 Abs. 1 und 2 DSGVO concerning the processing of your data in connection with direct advertising, if it is based on a balancing of interest.

### 1.8. Where do you lodge a complaint?
